that are simple to understand and least open to subjective interpretation. They wil be to:

- Count the number of deaths reported in the first paragraph, as well as the headlines, and include stories from the entire news section, not just the front page.
- Examine the sources for each story. We will count the number of
 - Column inches devoted to statements from officials on each side
 - o Times each side's officials are quoted first
- Determine whether the specific American connection to the conflict \$5 billion annual U.S. aid to Israel is covered fully and accurately. We will
- Count the number of times U.S. aid to Israel-Palestine is mentioned
- Evaluate the accuracy of this number. How often does it include both major segments of U.S. aid military aid and foreign aid as well as additional subsidies such as loan forgiveness programs.

John Stuart Mill said that the most formidable evil is "not the violent conflict between the parts of the truth, but the quiet suppression of half of it."

Conclusions

Provided the results of this preliminary examination. We believe the readers of the San Jose Mercury News, as well as all Americans, are entitled to full and accurate reporting on all issues, including the topic of Israel/Palestine, especially given that Israel is the highest recipient of US aid.

We assume that the San Jose Mercury News is as disturbed as we have been to find these shortfalls in its quest to provide excellent news reporting to its readers. Now that it has been alerted to these distortions in its Israel-Palestine coverage, we encourage the Mercury News to undertake whatever changes are necessary to provide accurate news coverage of this vital issue. We hope that the findings in our next report will show an increased level of accuracy in the Mercury News' coverage of this important issue.

The mission of If Americans Knew is to inform and educate the American public on issues of major significance that are unreported, underreported, or misreported in the American media.







Key Findings. From April through September, 2002, 140 Israeli deaths were reported in San Jose Mercury News front-page headlines compared with only 20 Palestinian deaths. During this time, there were actually 192 Israeli deaths and 383 Palestinian deaths (see B'Tselem, Israel's leading Human Rights organization, www.btselem.org).





In other words, while 73% of Israeli deaths were reported in front-page headlines, only 5% of Palestinian deaths were.



Introduction

f Americans Knew aims to issue a quarterly report card to major media across the country on their coverage of the Israeli-Palestinian conflict. The San Jose Mercury News is the first publication to receive a preliminary report, covering April through September of 2002.

The purpose for issuing this report is that it can help the media to understand where they are failing to accurately portray the Israeli-Palestinian conflict, and how they can improve their accuracy in the future.

In addition, we are making these reports public, as a way to help readers evaluate for themselves the reliability of their sources of information on this issue.

Yardstick for Measuring Accuracy

has been an exceptionally controversial topic. Therefore, while there are many potential yardsticks for measuring accuracy, for this initial report we chose criteria that could not be constued as at all subjective.

We counted the number of Israeli and Palestinian deaths the San Jose Mercury News reported in head-lines on the front page:

- · In absolute numbers, and
- As a percentage of total deaths for Israelis and Palestinians respectively

We chose this yardstick because it is simple, quantitative and relatively immune to subjective interpretation. In addition, we wanted to understand if the San Jose Mercury News demonstrates even-handed respect for human life, regardless of ethnic or religious origin.

Our final reason for choosing this yardstick was that front-page headlines are often among the most prominent aspects of coverage that a reader absorbs. We believe they play a disproportionate role in generating an overall impression about the conflict and the relative consequences for Israelis and Palestinians.

Next Steps

n order to better understand reporting on this topic, we will conduct a deeper investigation next time, while maintaining our objective of using yardsticks
